ID	Law Clinic	Main challenges in terms of legal aid provision
1	UKZN Law Clinic Durban	<p>The ratio of supervisor to student capacity is very challenging.</p> <p>In estates involving property transfers, there is not much that the clinic can do except to advise the client. E.g. we can't assist with the conveyancing, and finding conveyancing attorneys to do this has been virtually impossible- allied with clients not being able to pay property transfer-related costs.</p> <p>Both the Director and the Principal Attorney are full-time academic members of staff in addition to their Law Clinic designations; hence having to divide their time between the Clinic's tasks and lecturing, research and other 'academic staff' commitments.</p>
2	University of Venda Law Clinic	We have challenges of infrastructure, transport to court and community outreach programme, the university only supply us with one vehicle which is used for a wider area, practitioners have to drop each other at various courts and wait afterwards. It has been a promise that it would improve, but so far the same.
