5 Rhodes University Law Clinic	<p>The Clinic entered into a cooperation agreement with The Assumption Development Centre, situated in the township area, whereby we consult with clients every Thursday at the centre- hence enhancing our access to justice objectives. We have witnessed a steady growth in clients coming to the ADC for legal assistance. This saves indigent clients from having to take public transport for that initial consultation with an attorney.</p>
