1	UKZN Law Clinic Durban	Limited staff and funding (eg for disbursements).
2	Univen Law Clinic	Funding: We are highly affected as we are unable to meet all our desired projects, including equipping our students with a better practical understanding of what is required of them in the profession.
3	Nelson Mandela Metropolitan University Law Clinic	Shortage of preofessional staff, offices and office resources.
4	North West University Community Law Centre	Staff and student numbers (121) Funding.
5	Rhodes University Law Clinic	a) Continuation of case work handled by students, who are only in Clinic for about 27 weeks per year.B) Interpretation: the majority of clients are isiXhosa speakers, whilst only few students and practitioners are fluent

7	University of Johannesburg Law Clinic	We do not have a budget to assist clients with disbursements. Any case requiring experts canot be done properly as the clients do not have money to pay experts. There are too few attorneys appointed to deal effectively with the number of students and do their own court appearances. The number of students is rising.
8	University of Limpopo Campus Law Clinic	Insufficient personnel after the end of the DOJ Project. We are now sitting with only two candidate attorneys compared to the nine we had under the DOJ Project. Large numbers of students registering for our practical legal course putting the students / supervisor ratio out of balance. Traveling expenses are proving to be too costly.
9	North West University Law Clinic	Budgetary Constraints - running costs, telephone, travelling etc.
10	University of Pretoria Law Clinic	1.Demand outstrips capacity (certain times of the year).
		2.Non-permanency of staff members leads to turnover in staff
11	UWC Legal Aid Clinic	Funding, Resources and Capacity. There is not enough skilled staff to do human rights related litigation. We still operate ike a general practice. Quantity rather than quality due to funder demands.
12	Wits Law Clinic	The more funding we would have the more we would be able to assist. Large student numbers created problems. The demands of the university to conduct research and publish impacts not only on the provision of legal services, but also causes tensions between clinicians.
13	Legal Aid Clinic - Stellenbosch University	Finding financial support for salaries.
15	University of Fort Hare Law Clinic	There was no future strategic plans in terms of human capital as a result of which the Law Clinic found itself solely dependent on funding from external sources at the end of the contract period of funders. The Law Clinic suffered as a result of lack of human capital.
